Position Overview:

Green Schools Alliance seeks an experienced fundraiser for the position of Director of Development. This position offers the opportunity to work with a dynamic team that is deeply committed its mission and comprised of individuals who are experts in their field. The Director of Development will create and oversee the implementation of a strategic approach to fundraising which may include major gifts, corporate donations, grant solicitation, and in-kind resources. This position supervises our Strategic Partnership Manager.

Primary Duties and Responsibilities

Plan fund development activities

- Collaborate with the Board of Directors and Executive Director to create a fund development plan which increases revenues to support the strategic direction of the organization
- Work with the Board to create and implement a Board development strategy, including fundraising training.
- Implement the fund development plans in accordance with ethical fundraising principles
- Monitor and evaluate all fundraising activities to ensure that the fundraising goals are being achieved
- Monitor trends in the community or region and adapt fundraising strategies as necessary Organize fund development activities
 - Develop and manage timelines for various fundraising activities to ensure strategic plans and critical fundraising processes are carried out in a timely manner
 - Develop policies and procedures for the development department which reflect ethical fundraising practices
 - Prepare and submit grant applications as outlined in the fund development plan to generate funds for the organization
 - Work with program staff to determine appropriate grant and foundation opportunities
 - Manage grant and foundation reports in collaboration with program staff
 - Oversee the planning and execution of special fundraising events as specified in the fund development plan to generate funds for the organization
 - Identify and develop corporate, community and individual prospects for the organization's fundraising priorities
 - Oversee the administration of a donor mailing list and database which respects the privacy and confidentiality of donor information
 - Coordinate in-kind donations and make decisions regarding the issuing of receipts

Promote the organization

- Foster an understanding of philanthropy within the organization
- In collaboration with the Director of Communications, develop a comprehensive communication plan to promote the organization to its donors and maximize public awareness of the fundraising activities of the organization
- Coordinate the design, printing and distribution of marketing and communication materials for development efforts, with the Communications Department.
- Build relationships with community stakeholders to advance the mission and fundraising goals
 of the organization
